BWG inventoried and examined governance structures, fundraising strategies, local and state policies and

Bransom Working Group (BWG) has the expertise to assist with both exploration and implementation phases of Better Together Fund grants. Phase 1 support might include organizational SWOT assessments, asset mapping and analysis, program inventories, and partnership feasibility studies. Phase 2 assistance might include partnership convenings, strategic planning, visioning exercises, and business model development. Phase 3 implementation support might include identifying benchmarks and metrics, developing timelines, and articulation of a collaborative agreement and/or memorandum of understanding. Since 2017, Bransom Working Group has provided The Wallace Foundation with project management and strategic communications services as part of the foundation's Partnerships for Social and Emotional Learning Initiative. PSELI is a four-year effort to help children in six U.S. cities gain greater opportunities for social and emotional learning and to better understand how schools and out-of-school-time providers can work together to align and improve those opportunities. BWG has co-developed new ways of working across multiple cities. Examples include developing new communications channels and designing and field testing a new project manager position, which is now being duplicated across the foundation's departments. BWG also assists Wallace Foundation staff by writing formal papers that are presented to the



foundation's board members. Past papers have included such contributions as funding rationales, implementation and sustainability analyses, and discussions of opportunities and challenges in the field. BWG has also worked with the U.S. Department of Education to analyze arts education model dissemination grantees' programs over three years, identifying common best practices in the field. We have also consulted with RAND Corporation, serving as district lead and data coordinator for a national randomized controlled trial to study the effectiveness of voluntary summer programming. This included five weeks of classroom observations, analysis of 20+ interviews and the creation of a reader-friendly executive summary detailing outcomes.
